

FLUKE GIFT WITH PURCHASE OFFICIAL RULES

Important: Please read these Official Rules before entering this online promotion (the "Promotion").

By mailing in the redemption form found on the Fluke Gift with Purchase Promotion webpage and/or participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

Eligibility and Terms: Gift with purchase is available for all purchases of a "Qualifying Fluke Purchase" made from an authorized Fluke distributor including purchases made through the Fluke online store, purchased in the United States or Canada between March 31, 2014 and June 30, 2014. See the list of authorized distributors on <http://www.fluke.com/fluke/usen/wheretobuy>. Void where prohibited by law.

All qualified redemptions will be fulfilled if the redemption is found to be eligible and meets the requirements. Purchase must be made during the promotion period. A receipt may only be submitted once; receipts submitted more than once are considered invalid. Supplies are not limited.
