

## **FLUKE COOL COMBO FOR COOLING SEASON GIFT WITH PURCHASE OFFICIAL RULES**

**Important: Please read these Official Rules before entering the promotion (the "Promotion").**

**By participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.**

**1. Eligibility and Term.** Gift with purchase is available for all purchases of a "VT02 Visual IR Thermometer" made from an authorized Fluke distributor in the United States or Canada between June 1, 2013 and September 30, 2013. See the list of authorized distributors on <http://www.fluke.com/fluke/usen/wheretobuy> or <http://www.fluke.com/fluke/caen/wheretobuy>. Void where prohibited by law. A receipt may only be submitted once for each purchase; receipts submitted more than once are considered invalid and may not be combined with other gift with purchase offers. Multiple receipts may be submitted for each VT02 purchased as long as a qualifying redemption form is submitted with each receipt. Responses postmarked after 30 days of purchase will be invalid and will not be returned. Redemption forms must be filled out accurately to qualify. This offer is not available through Fluke sales staff, Fluke service centers or Fluke corporate offices.

In order to receive gift with purchase, participant must complete the redemption form in its entirety. All requested contact information must be provided for your entry to be valid. A copy of the purchase receipt or invoice must be included that clearly shows each Fluke product. Entries will not be returned. Entries must be submitted within 30 days of purchase. All entrants and entries are subject to verification by Sponsor. 5. Program Details. For each qualifying purchase of a Fluke VT02 Visual IR Thermometer that is made within the Program Period, provide proof of purchase/receipt and completed redemption form. Upon validation of the form and proof of purchase, Fluke Corporation will send a 902 Clamp Meter, free of charge, to the address listed on the form. All costs associated with shipping and handling will be paid by Fluke Corporation. Please allow up to 60 days from the submission date of the form and proof of purchase before you receive the 902 Clamp Meter.

6. Gift with Purchase Gifts and Value.

The manufacturer's suggested retail price (MSRP) of the 902 Clamp Meter is \$299.95.

If the 902 Clamp Meter is unavailable, Fluke Corporation, in its sole discretion, reserves the right to substitute it with another gift of equal value. No cash substitutes allowed except at Fluke Corporation's sole discretion due to gift unavailability for any reason. Eligibility for gift with purchase is non-transferable and non-assignable.
